ORDER

1. Provisional affiliation was granted to the self financing B.Ed. programme at St.Gregorios Teachers' Training College (Un-Aided), Meenangadi, Wayanad with Social Science (38 Seats), Physical Science(16 seats), Malayalam (10 seats), English (20 seats) & Mathematics (16 seats) as optional subjects during the academic year 2005-06 ,vide U.O. read as (1).
- 2 . National Council for Teacher Education (NCTE) permitted the college for conducting B.Ed. programme of 2 years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-'16 onwards vide paper read as (2). Re-distribution of seats in tune with the (NCTE) regulation-2014 and removal of optional subject, Malayalam, with effect from the academic year 2015-16 was granted vide U.O. read as (3).
3. As per U.O. read as (4) , it was resolved to grant Continuation of Provisional Affiliation to Teacher Education Colleges as usual in the beginning of the academic year as in the case of other programmes, without insisting extension of the approval from NCTE.
4. Revised permanent seat distribution w.e.f. the academic year 2020-'21 was sanctioned, along with re-arrangement of seats, for 2020-'21 academic year, vide U.O. read as (5).
5. Continuation of Provisional Affiliation was granted to B.Ed. programme for the academic year 2023-'24 conditionally, subject to submission of renewed NOC from Government of Kerala vide U.O. read as (6). Later, Government of Kerala renewed NOC for the academic year 2023-'24, vide G.O. read as (7).
6. The Principal has submitted application for Continuation of Provisional Affiliation to B.Ed. programme for the academic year 2024-'25, vide paper read as (9).
7. The Government of Kerala have renewed NOC for 2024-'25, vide G.O. read as (10).
8. Considering the matter in detail, sanction has been accorded by the Vice Chancellor,
(i) to grant Continuation of Provisional Affiliation to the self financing B.Ed. programme in St. Gregorios Teachers' Training College(Un-Aided), Meenangadi, Wayanad , as detailed below for the academic year 2024-'25 and

(ii) to absolutize the U.O. No. 2998/2023/Admn dated 20.02.2023 granting Continuation of Provisional Affiliation conditionally during 2023-'24 academic year, since the College has produced the renewed NOC from the Government of Kerala.

9. Orders are issued accordingly subject to the following terms and conditions:

- i. The Principal shall strictly follow the syllabi, available on the University website (www.uoc.ac.in) for selecting complementary courses..
- ii. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- iii. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take stringent measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iv. Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- v. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders,
- vi. The conduct of University Examinations of any sort including that of the SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- vii. The college is liable to comply with the general conditions stipulated in the renewed NOC from the Government of Kerala for the academic year.
- viii. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- ix. Violation of any of the above will lead to the cancellation of affiliation.
